MINUTES OF THE EXTRAORDINARY SHAREHOLDERS' MEETING OF THE COM-PANY

- LUCA GARAVOGLIA, born in Milan on 27 February 1969, who declares that he intervenes in the present deed in the capacity of Chairman of the Board of Directors and representing the company "DAVIDE CAMPARI-MILANO S.p.A.", with registered office at via Sacchetti 20, Sesto San Giovanni, where he is domiciled for the purposes of his office, with share capital of € 58,080,000.00, tax code and Milan Companies Register number 06672120158, R.E.A. [Reperto Economico Amministrativo, Economic Administrative Index] 1112227.

I the Notary am certain of the personal identity of the appearing party, who asks me to receive the minutes of the extraordinary shareholders' meeting of the above-named company.

The appearing party, having assumed the chairmanship of the meeting in accordance with the law, the Bylaws (Art. 12 of the Bylaws) and the DCM Shareholders' Meeting Regulations (Art. 4.1 of the Shareholders' Meeting Regulations).

#### HE DECLARES

- that today, in this place at 09:30, the duly convened extraordinary shareholders' meeting of the company was held to discuss and deliberate on the following:

#### **AGENDA**

### Extraordinary part

- 1. A proposal to renew, for a further five years from the date of resolution, the powers given to the Board of Directors to increase capital, against payment or otherwise, with express recognition of the option to additionally adopt the resolutions pursuant to Article 2441, paras. 4 and 5 of the Italian civil code, as well as to issue bonds convertible into shares of the Company, securities (not only bonds) that allow subscription to new shares and participating financial instruments pursuant to Article 2346, para. 6 of the Italian civil code; approval of the resulting amendments to the Articles of Association, numbering of paragraphs in article 20 and correction of mistake in paragraph 2 of the same article.
- that the notice of meeting was published both on the company's website and in the daily newspaper "Il Sole 24 ore" on 27 March 2015;

- that the documentation relating to today's meeting has been made available at the registered office and on the authorised storage platform 1INFO (www.linfo.it), as well as on the company's website (www.camparigroup.com/it/governance/assemblea-azionisti);
- that for the Board of Directors:
- Saccardi Stefano, born in Milan on 12 May 1959, is present;
- Marchesini Paolo Rinaldo Antonio, born in Milan on 15 March 1967, is present;
- Kunze-Concewitz Robert, born in Istanbul (Turkey) on 7 April 1967, is present;

- that for the Board of Statutory Auditors:
- Libroia Pellegrino, born in Milan on 28 September 1946, Chairman, is present;
- Colombo Enrico Maria, born in Milan on 10 April 1959, is present;
- Lazzarini Chiara, born in Milan on 9 August 1967, is present;
- that pursuant to Art. 11 of the Bylaws and Art. 83-sexies of Legislative Decree 58/1998 (Testo Unico della Finanza [Consolidated Law on Finance] or "TUF"), the right to take part in the Meeting is evidenced by a communication made by the intermediary with whom the share is registered, in favour of the person who on the basis of the accounting records as at the seventh trading day preceding the date set for the Meeting (i.e. 21 April 2015) holds the right to vote;
- that the list of names of the parties taking part in person or by proxy, complete with all data required by CONSOB, is annexed to these minutes under the letter "A", and that from this list it will be possible to obtain the names of the shareholders who vote in favour of the proposed resolutions;
- that the conformity of the proxies with the provisions of Art. 2372 of the Civil Code has been verified;
- that checks have been made on the eligibility for voting of parties who, on the basis of the available information, hold investments that involve obligations of authorisation or communication;
- that Group employees and technical and support staff are also present to ensure the proper conduct of the proceedings;
- that the proceedings of the meeting are being recorded in

- that the notice of meeting contained information on procedures for the submission of requests, and that no requests for additions to the agenda were received pursuant to Art. 126-bis of the TUF;
- that questions were, however, received from a number of shareholders concerning the items on the agenda by the third trading day preceding the Meeting, pursuant to Article 127-ter of the TUF and as indicated in the Notice of Meeting;
- that the shareholder Etica SGR has given prior notice of the text of its intervention at the Meeting and that, since the subject of the intervention pertains in part to the first item on the agenda for the extraordinary part of the Meeting, the said shareholder is invited to take the floor when the relevant discussion takes place;
- that according to the Shareholder Register, supplemented by the communications received and other available information, the following parties hold, directly or indirectly, more than 2% (two per cent) of the share capital of € 1,161,600.00 (one million one hundred and sixty-one thousand six hundred point zero):
- "Alicros S.p.A.": 296,208,000 (two hundred and ninetysix million two hundred and eight thousand) shares, equal to 51% (fifty one per cent) of the share capital;
- "Cedar Rock Capital Ltd.": 62,936,560 (sixty-two million nine hundred and thirty-six thousand five hundred and sixty) shares, equal to approximately 10.84% (ten point eight four per cent) of the share capital;
- "Morgan Stanley Investment Management Ltd.": 11,868,704
   (eleven million eight hundred and sixty-eight thousand seven hundred and four) shares, equal to approximately 2.04% (two point zero four per cent) of the share capital;
- that there are no other shareholders, other than those stated above, holding an equity investment of more than 2% (two per cent) who have notified Consob and the company pursuant to Article 120 of the TUF and Article 117 of Consob Resolution no. 11971 of 14 May 1999, concerning the obligation to notify significant shareholdings;
- that also present is the shareholder "THE OAKMARK INTERNATIONAL SMALL CAP FUND", holder of 12,171,769 (twelve million one hundred and seventy-one thousand seven hundred and sixtynine) shares, equal to approximately 2.1% (two point one per cent) of the share capital, which has not notified Consob pursuant to Article 120 of the TUF and Article 117 of Consob Resolution no. 11971 of 14 May 1999, since it qualifies for the exemptions cited in Art. 119-bis, nos. 7 and 8, of the said Resolution; the shareholder, pursuant to the above-mentioned Art. 119-bis, no. 8, declares that to the best of its knowledge it is subject, in the country of origin, to forms of supervision by an authority under public control or recognised

- that since no shareholder has yet acquired the double vote right pursuant to Article 6 of the Bylaws for all shareholders, including those indicated above who hold equity investments of more than 2%, the number of shareholdings and voting rights are the same, and therefore at this Meeting there will be no separate counting of shareholdings and voting rights.

The Chairman reports that on the basis of the documentation supplied by the staff of "Simon Fiduciaria S.p.A." and by the Chairman himself, responsible for carrying out checks on the right to intervene at the Meeting and for collecting voting slips, there are 393 (three hundred and ninety-three) shareholders present for twelve heads, holders of shares in person or represented by proxies, in accordance with documentation produced, of 458,474,194 (four hundred and fifty-eight million four hundred and seventy-four thousand one hundred and ninetyfour) ordinary shares equal to approximately 78.938394% (seventy-eight point nine three eight three nine four per cent) of share capital ο£ € 58,080,000.00, consisting 580,800,000 shares with a nominal value of € 0.10 each:

specifically, 24,773 (twenty-four thousand seven hundred and seventy-three) in person and 458,449,421 (four hundred and fifty-eight million four hundred and forty-nine thousand four hundred and twenty-one) by proxy.

The Chairman

#### DECLARES

the meeting validly convened to deliberate on the agenda.

The Chairman explains the Report of the Board of Directors drawn up pursuant to Art. 72 of Consob Resolution no. 11971 of 14 May 1999 and Art. 125-ter of the TUF, and made available to the public pursuant to the applicable legislation.

The explanatory report approved by the aforesaid Board of Directors was made available to the public on 27 March 2015, through the centralised regulated information storage platform known as "lInfo" managed by Computershare S.p.A. pursuant to Art. 113-ter, paragraph 4, b, of the TUF.

In accordance with the resolutions adopted by the Shareholders' Meetings of 24 April 2006 and 30 April 2010, the Chairman proposes the renewal, for five years from the date of the resolution, of the authorisation for the Board of Directors to increase the share capital, either as a bonus or against payment, with express recognition of the power also to adopt the resolutions referred to in Article 2441, paragraphs 4 and 5, of the Civil Code, as well as to issue bonds convertible into shares of the Company, or securities (which may be other than bonds) that allow the subscription of new shares and the participatory financial instruments referred to in Article 2346, paragraph 6, of the Civil Code. All of the above through amendment of Article 5 of the current Bylaws.

The Chairman also proposes to use the occasion of the above

amendment of the Bylaws to number the paragraphs of the articles of the Bylaws and to correct a material error made in previous amendments of the Bylaws, mentioning Article 22 rather than the article following the second paragraph of Article 20.

For a more detailed description of the purposes and procedures of the authorisation requested, the Chairman refers those present to the above-mentioned special explanatory Report of the directors.

The discussion then takes place, including the intervention of Etica SGR, to whom the relevant replies are given.

Before moving on to the vote, Mr Luca Garavoglia explains that the voting will be carried out "differently", counting only votes against and abstentions, for which the relevant shareholders are therefore requested to hand the relevant voting slips to the staff at the voting stations, while shareholders voting in favour need not do anything: as permitted by Art. 10.3 of the Shareholders' Meeting Regulations.

The Chairman notes that, at the moment when the resolution is put to the vote, the same shareholders who were present when the Meeting was declared open are present.

He also gives a reminder that anyone who intends to leave the Meeting before its conclusion and before the voting must inform the responsible staff accordingly so that the number of votes present can be updated pursuant to Art. 4.9 of the Shareholders' Meeting Regulations.

Based on the documentation provided by the staff of Simon Fiduciaria S.p.A., Mr Luca Garavoglia declares the outcome of the vote, with the following results:

- in favour 359,584,717 (three hundred and fifty-nine million five hundred and eighty-four thousand seven hundred and seventeen) shareholders equal to 78.430743% (seventy-eight point four three zero seven four three per cent) of the ordinary shares represented;
- against 98,598,709 (ninety-eight million five hundred and ninety-eight thousand seven hundred and nine) shareholders equal to 21.505836% (twenty-one point five zero five eight three six per cent) of the ordinary shares represented;
- abstentions 290,768 (two hundred and ninety thousand seven hundred and sixty-eight) shareholders equal to 0.063421% (zero point zero six three four two one per cent) of the ordinary shares represented.

All of the above according to the report showing the outcome of the vote, which is annexed to these minutes under the letter "B" and forms an integral part hereof.

The Meeting, with the majorities stated above

#### RESOLVES

\* to approve the following new text of Art. 5 of the Bylaws: "The company's share capital is  $\in$  58,080,000.00 (fifty-eight million eighty thousand/00), represented by 580,800,000 (five

hundred eighty million eight hundred thousand) shares with a

par value of

€ 0.10 (zero point one) each.

The company's share capital of € 58,080,000.00 (fifty-eight million eighty thousand/00) has been entirely subscribed and paid up. For five years following the resolution of the April 30, 2015 extraordinary shareholders' meeting, the Board of Directors shall have the power to:

- (i) increase the company's share capital once or more than once, for a price and/or free of charge, possibly in more than one instalment, up to a total par value of  $\ensuremath{\mathfrak{C}}$  100,000,000.00 (one hundred million/00) by issuing new shares; and
- (ii) the power to issue, in one or more instalments, bonds convertible into shares and/or securities (including securities other than bonds) permitting subscription of new shares up to a total share capital par value of  $\[Ellion$  100,000,000.00 (one hundred million/00), provided the amount issued each time does not exceed the legal limit for bond issues.

In accordance with the applicable provisions of the law, the power described in the paragraph above may also be exercised with limitation and/or exclusion of the right of first call, in the following cases:

- a) in the case of a share capital increase to be paid up by contribution in kind, if it allows the Company to acquire one or more assets which are prudently assessed by the Board of Directors as being of strategic importance for achievement of the company's purpose;
- b) in the case of a share capital increase to be paid up in cash,
- if the economic conditions and terms of sale (including, simply by way of example, third parties' commitments to subscription) are prudently assessed by the Board of Directors as being advantageous for the Company;
- c) in the case of a share capital increase in kind or in cash, if it constitutes part of a wider-ranging industrial agreement which is prudently assessed by the Board of Directors as being of strategic importance to the Company.

In the case of issues of shares with limitation and/or exclusion of rights of first call, the Board resolution concerning the increase must explain the presence of one of the three circumstances identified in the previous paragraph and the criteria applied to determination of the subscription price.

In addition to the specific opinions required by the applicable law, the congruity of the issue price must first be assessed by a primary bank, and the issue price (including any share premium) may not be any lower than the value of consolidated net worth per share as stated in the company's most recent duly approved financial statements.

Within the limits set by the law and by Article 5, the Board of Directors is given the broadest power to establish the

methods of placement in each case (public sale and/or private placement), category (ordinary or special shares, including shares without voting rights), any equity and/or administrative privileges, issue price and share premium (differentiated as necessary if shares of different types are issued at the same time) of new shares, and shares serving convertible bonds and/or securities (other than bonds) permitting subscription of new shares.

The Board of Directors is also given the power to make decisions regarding any requests for issuing shares and/or convertible bonds and/or securities (other than bonds) permitting subscription of new shares on one or more public stock exchanges in Italy or abroad. It is understood that, on the basis of the regulations stated in paragraphs four, five and six above (to be applied mutatis mutandis), the power described in this article must be considered also delegated with reference to issuing of financial instruments involving equity and/or administrative rights, excluding voting rights in the shareholders' meeting, for contribution of cash and/or assets in kind and/or work or services.

Subscription of such financial instruments must be offered as an option to the Company's shareholders, except in the circumstances described in letters a) and/or b) and/or c) of paragraph four above (noting that, for this purpose, contribution of work and services is considered equivalent to contribution of assets in kind).

If financial instruments are issued for a contribution of work or services, the Board of Directors must determine the sanctions applicable in the event of defaulting on these obligations.

The Board of Directors will also determine the equity and/or administrative rights consequent upon financial instruments, while it is understood that in no case will owners of financial instruments issued be granted the right to appoint more than one third of the members of the Board of Directors and/or the right to more than a 30% (thirty percent) share in the profits or available reserves appearing in the financial statements.

The Board of Directors will also have the right to decide on incorporation of financial instruments into securities for circulation, and the power to request admission for negotiation on one or more public stock exchanges in Italy or abroad.

\* to number the paragraphs of the Bylaws with the correct reference to Art. 20, paragraph 2, approving the updated version of the Bylaws, which are annexed to these minutes under the letter "C" and form an integral part hereof, with the appearing party dispensing me from reading them aloud.

There being nothing further to discuss, since no-one requests the floor, the Chairman declares the ordinary part of today's Meeting closed at 10:00.

The costs relating to and arising from this deed will be borne by the company.

The appearing party dispenses me from reading aloud and showing the annexes, whose content he declares that he knows.

Upon request, I the Notary receive this deed, which I read aloud to the appearing party, who approves and signs it at 10:00.

This deed is partly typed by a person whom I trust and partly completed by hand by me, the Notary, on four folio sheets comprising sixteen pages up to this point.


